 - i. Abstract of minimum 250 – maximum 500 words and 4-6 Keywords.
 - ii. The abstract should stress upon the purpose of the paper, design/methodology/approach adopted, findings and originality/novelty of the paper. The following three subheadings **are optional and can be included if applicable**.
 - Research limitations/implications**
 - Practical implications**
 - Social implications**
 - iii. Font Size of the abstract body: Times New Roman, 12pt, with 1.5-line space, justified.
